BMW Board of Directors Job Description and Commitment

Position Description: A Director is a member of a team (BMW board) committing his/her time, talent, treasure and testimony to accomplish the mission and vision.

BMW mission: Make reproducing disciples of Jesus among the Bengali people.

BMW vision: Bangladesh is 2% saved and a sending nation.

Assumptions:

- 1. Have a passion for the mission, purpose, values, policy, and strategic direction of BMW.
- 2. Encourage, support, equip, serve and assist the Executive Director as a unified team.
- 3. Self-assess personal involvement in relation to annual board involvement goals.

Qualifications:

- 1. Lifestyle and heart demonstrating a dedicated and mature Christ-follower.
- 2. Committed to BMW's mission and methods.
- 3. Willing to make BMW a top priority of service.
- 4. Fully invested donor of time, talent, treasure, and testimony.
- 5. Agree with BMW's doctrinal statement.

Responsibilities:

- 1. Encourage and support the staff.
- 2. Represent BMW with enthusiasm and act with professionalism.
- 3. Attend all regular and special board meetings and be prepared to discuss agenda items.
- 4. Serve on one or more task forces or committees.
- 5. Participate in approving and achieving the annual budget and strategic plans.
- 6. Pray for the ministry regularly.
- 7. Participate in 100% of the board's development activities.
- 8. To keep the bi-laws and meet the requirements of state government.
- 9. Live out the BMW code of values (on the back of this sheet).

Term: A Director will be elected by a majority of the board and will serve a three-year term or an unexpired portion of a three-year term. After six consecutive years on the board an individual is eligible to serve again after a minimum of one year off the board.

Compensation: This is a volunteer role.

Code of Values: As a BMW board member I pledge...

- 9. To regard everyone as right from their own perspective.
- 10. To respond to issues and requests in a timely fashion.
- 11. To realize that success is the result of clear, cooperative, positive thinking.
- 12. To fully acknowledge that this is a great work of God...He supplies, directs, and enables us. We seek Him in all things.
- 13. To advance my understanding of the progress of the Great Commission in the world in general and in BMW in particular.
